DH & CITY OF DOTHAN SUBRECIPIENT AGREEMENT: 02-06-2024 the City of Dothan, approved Resolution 2024-25 to enter into a subrecipient agreement with Dothan Housing (DH) and will be assisting DH, through the budgeting of Community Development Block Grant (CDBG) Funds for the purpose of administering the City's new Rental Rehabilitation Program. The City of Dothan has budgeted the amount of \$200,000.00 for the new Rental Rehabilitation Program to rehab 20-40 eligible units.

DEPARTMENT UPDATES:

HOUSING & RESIDENT SERVICES:

ASSET MANAGEMENT: Dothan Management Group collected 96% of TAR (tenant receivables) for the month of January. A total of 184 work orders were issued and completed with 16 being emergency work orders. All emergency work orders were abated within 24 hours and all routine work orders within 2 days. The average unit turnaround days for January was 3. 80 Housekeeping Inspections were completed in the month of January.

RESIDENT SERVICES: Collaborated with Dothan Management Group (DMG) to host the residents' youth basketball team at the 30th Annual SERC MLK Basketball and Cheer Tournament in Opelika, AL from Thursday, January 11, 2024, to Sunday, January 14, 2024. Eleven youth participated in the tournament and competed against several other housing authority teams. An application was completed for the Resident Board of Commissioner representative to become a HUD Resident Ambassador for PH Resident Coalition and Capacity Building Training for the Spring/Summer of 2024. The ambassador within the training program would increase skills to strengthen the capacity of Resident Councils, networking connections and build partnerships to assist the PHA with their mission. If awarded this opportunity the representative will be able to bring back great knowledge and skills to the remaining members of the board. Continues to provide the various available Scholarship opportunities to all eligible residents and families.

MARKETING & FUNDRAISING: Our first quarter goal is to educate the public on all platforms about who we are, what we do, and basic facts about our affordable housing properties. Through social media postings and participation in external events, we have engaged our residents, potential partners, and the community. Social Media Engagement with Followers and Fans, Impressions, Pages and Profile Reach continue to increase. Our new website is on track to launch by March 31st. Benefits to the new website include a user-friendly layout, increased ADA accessibility measures, more creative control, and cost savings exceeding 40% for the agency.

Dothan Housing attended the Dothan Area Chamber of Commerce (DACC) Spotlight on Business. 01-18-2024 Dr. Michael Threatt DH's Chief Operating Officer (CHO) graduated from the Rutgers' Executive Director Education Program (EDEP). 01/24/2024 Wiregrass Area Homeless Connect and Point-In-Time Count 2024 was held at Our Community's Michael C. Patton Event Center. 01/30/2024 Dr. Tamara Berry-Andrews DH's Chief Housing Officer (CHO) was selected for the National Conference Presentation. 02/08/2024 a local Veteran received Wiregrass' First VASH Voucher.

OFFICE OF THE CHO: DH owns an abundance of undeveloped land. We are trying to determine what we can put on these lots. We will develop comprehensive plans. To add to our housing stock, the former DH Central Office located at 602 S. Lena Street is being redeveloped for two 2-bedroom units; two 1-bedroom units; the units will be fully accessible, and a laundry facility will be on site. The project is ongoing. Bids went out 02-22-2024.
