BE IT RESOLVED by the Board of Commissioners of the Housing Authority of the City of Dothan, Alabama (DHA) as follows; and

WHEREAS, the Board of Commissioners shall duly elect a Chairperson and a Vice-Chairperson for this Board of Commissioners at its Annual Meeting, and

WHEREAS, the By-Laws of the Housing Authority of the City of Dothan, Alabama adopted November 9, 2005 by Resolution No. 2005-16; revised by Resolution No. 2019-20 on October 9, 2019; revised by Resolution No. 2021-03 on January 13, 2021; revised March 17, 2021 by Resolution No. 2021-11 and further revised December 8, 2021 by Resolution 2021-58; states in Article II-Officers, Section 1: The officers of the Authority shall be a Chairperson, and a Vice-Chairperson and a Secretary-Treasurer (who shall be the Executive Director/Chief Executive Officer {CEO}). WHEREAS, Section 511 of the Quality Housing and Work Responsibility Act (QHWRA) of 1998 implemented the requirement that each housing authority shall submit to HUD an Agency Plan composed of the Annual Plan, Five-Year Plan, any significant amendments, substantial deviations or modifications; and

WHEREAS, in order to comply with HUD regulations, DHA has developed an Annual Plan for FY 2024 beginning on January 1, 2024, and Revision #4 for the FY2020-2024 Five-Year Plan including the Moving to Work (MTW) Supplement Plan as an expansion PHA under the Landlord Incentives Cohort #3 including previous significant amendments from prior year Capital Fund Program (CFP) substantial deviations or modifications as it relates to the SVC for regulatory uses under the HCV program and MTW fungibility criteria, and

WHEREAS, a Public Housing Authority (PHA) will advise HUD, its residents, and members of the public of the housing authority's mission for serving the needs of low-income, very low-income, and extremely low-income families and the housing authority's strategy for addressing those needs; and

WHEREAS, the COVID-19 pandemic challenged DHA to create a different platform for sustainability by "thinking outside of the box" and becoming a housing authority of the future. This was done through its digital transformation initiative and the implementation of the Purpose 2025: FY2022-2024 Strategic Plan; and

WHEREAS, DHA answered the challenge of evolution through transformational leadership and acknowledged the paradigm shift of public housing authorities (PHAs) moving from paper to the cloud and streamlining its operations through technology by embracing an online platform. Therefore, DHA has posted this information on its website and Facebook; and

WHEREAS, DHA establishes goals and objectives that assist in meeting the needs of the residents of the City of Dothan, including surrounding areas of the Wiregrass Metro Area (WMA) and

WHEREAS, DHA is committed to improving and expanding affordable housing opportunities for its Wiregrass Regional Voucher Program (WRVP) in the counties of Houston, Geneva, Dale, Henry, and Coffee; and

WHEREAS, DHA is consulted and participates in developing the Consolidated Plan of the City of Dothan and the Analysis of Impediments to Fair Housing Choice to comply with all applicable civil rights nondiscrimination and ensure equal housing opportunities. DHA also certifies that it complies with all Fair Housing laws for all public and affordable housing programs. DHA also certifies that it complies with Title VI of the Civil Rights Act of 1964, the Fair Housing Act of 1968, section 504 of the Rehabilitation Act of 1973, title II of the Americans with Disabilities Act of 1990, and the Affirmative Furthering Fair Housing (AFFH) law; and

WHEREAS, in March 2022, DHA amended the agency's Annual Contribution Contract (ACC) in connection with the PHA's designation as a participant in the expansion of the MTW demonstration pursuant to Section 239 of the Consolidated Appropriations Act, 2016, P.L. 114-113; 129 Stat. 2897 (2016 MTW Expansion

The PHA's participation in the expansion of the MTW demonstration shall be governed by the MTW Operations Notice for the Expansion of the MTW Demonstration as it is issued as it is and may be amended in the future or any successor notice issued by HUD; and

WHEREAS, DHA was granted flexibility and authority to develop policies in accordance with MTW for Expansion Agencies Operations Notice (Federal Register/ Vol. 85, NO. 168) FR/5994-N-05 outside the limitations of specific HUD regulations and provisions. DHA has the flexibility to apply fungibility to its public housing operating fund (OF), CFP, HCV HAP, and Administrative Fee funding. Therefore, DHA plans to utilize its fungibility and shift all of its remaining public housing CFP and OF, including all reserves according to its SVC, and transfer them to its HCV program based on the closeout of its public housing program; and

WHEREAS, DHA has the flexibility to apply fungibility among any CFP project not already in the Five-Year Action Plan; any other event that the DHA determines to be a significant amendment or modification of an approved annual plan and/or CFP Five-Year Action Plan; any purposes under SVC of remaining public housing funds including all reserves, and any purposes that PH/CFP reserves are subject to offsets as part of future Congressional appropriations acts that Congress has approved as an MTW Expansion Agency under the Landlord Incentives Cohort #3.

WHEREAS, DHA held a Public Hearing on October 10, 2023, at 11:00 a.m.; and

WHEREAS, DHA held a Public Hearing on December 19th at 11:00 a.m.; and

WHEREAS, DHA held a Public Hearing on April 16th at 5:30 p.m.; and

Therefore, DHA had to resubmit the Annual, Five-Year, and MTW Supplemental Plans and go through the Public Notice and Public Hearing process; and



NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Housing Authority of the City of Dothan, Alabama, as follows:

RESOLUTION 2024-08

BE IT RESOLVED by the Board of Commissioners of the Housing Authority of the City of Dothan (DHA) as follows; and

WHEREAS, Congress enacted the Moving To Work (MTW) demonstration program in 1996, in which a limited number of PHAs were selected. The 2016 MTW Expansion Statute allows HUD to increase the program's size from 39 to 139 agencies. The notice indicates that there will be 100 new PHAs that will be selected for the MTW expansion through the following methodology: 50 PHAs must have 1,000 or fewer public housing units or housing vouchers, 47 PHAs must have between 1,001-6,000 public housing units or housing vouchers, and only 3 PHAs have between 6,001-27,000 public housing units or housing vouchers. HUD recently designated 41 new MTW agencies under Cohort #1 and #2; and

WHEREAS, on Thursday, January 27, 2022, the U.S. Department of Housing and Urban Development (HUD) announced the Landlord Incentives cohort for the MTW Demonstration Expansion. Through evaluation of the Public Housing Agencies (PHAs) involved with this cohort, HUD will be able to determine the overall impact of landlord incentives and their impact on HUD's Housing Choice Voucher (HCV) Program. In a historic moment for the agency, DHA has been selected to join this invaluable cohort; and

WHEREAS, in March 2022, DHA amended the agency's Annual Contribution Contract (ACC) in connection with the PHA's designation as a participant in the expansion of the MTW demonstration pursuant to Section 239 of the Consolidated Appropriations Act, 2016, P.L. 114-113; 129 Stat. 2897 (2016 MTW Expansion Statute) and Section 204 of the Departments of Veterans Affairs and Housing and Urban Development and Independent Agencies Appropriations Act, 1996, P.L. 104-134; 110 Stat. 1321-281 (1996 MTW statute). The PHA's participation in the expansion of the MTW demonstration shall be governed by the MTW Operations Notice for the Expansion of the MTW Demonstration as it is issued as it is and may be amended in the future or any successor notice issued by HUD; and

WHEREAS, DHA was granted flexibility and authority to develop policies in accordance with MTW for Expansion Agencies Operations Notice (Federal Register/ Vol. 85, NO. 168) FR/5994-N-05 outside the limitations of specific HUD regulations and provisions. DHA has the flexibility to apply fungibility to its public



housing operating fund (OF), CFP, HCV HAP, and Administrative Fee funding. Therefore, DHA plans to utilize its fungibility and shift all of its remaining public housing CFP and OF, including all reserves according to its SVC, and transfer them to its HCV program based on the closeout of its public housing program; and

WHEREAS, DHA has the flexibility to apply fungibility among any CFP project not already in the Five-Year Action Plan; any other event that the DHA determines to be a significant amendment or modification of an approved annual plan and/or CFP Five-Year Action Plan; any purposes under SVC of remaining public housing funds including all reserves, and any purposes that PH/CFP reserves are subject to offsets as part of future Congressional appropriations acts that Congress has approved as an MTW Expansion Agency under the Landlord Incentives Cohort #3; and

WHEREAS, DHA is committed and dedicated to complying with the MTW objectives under the demonstration program enacted by Congress in 1996, under which a limited number of public housing authorities test ways to increase the cost-effectiveness of federal housing programs, to increase housing choices for low-income families, and to encourage greater economic self-sufficiency of assisted housing residents; and

WHEREAS, the MTW Demonstration would allow DHA to design and test innovative, locally designed housing and self-sufficiency strategies for low-income families, permitting PHAs to use assistance received under Sections 8 and 9 of the United States Housing Act of 1937. Specifically, the third cohort of the MTW Expansion will evaluate landlord incentives and their effect on landlord participation in the HCV Program for DHA; and

WHEREAS, DHA will comply with the MTW Operations Notice as an "MTW agency" based on the requirements for the implementation and continued operation of the expansion of the MTW demonstration program pursuant to Section 239 of the Fiscal Year 2016 Appropriations Act. DHA will operate under the terms of the MTW Operations Notice according to the 2016 MTW Expansion Statute; and



WHEREAS, DHA is uniquely positioned to work very effectively with HUD in this endeavor to meet the three statutory goals of the MTW Demonstration and HUD's Office of Policy, Development & Research (PD&R) to monitor and provide statistical analysis of the MTW activities implemented in the WMA; and

WHEREAS, DHA is excited to contribute to evidence-based research for the MTW Landlord Incentives cohort by streamlining its HCV Program operations. DHA understands the importance of thinking outside the box, focusing on best practices, and providing creative housing solutions to serve the most vulnerable with regulatory flexibility to merge funding streams and design innovative policies that can be replicated throughout the country; and

WHEREAS, the regulatory flexibilities associated with the MTW Landlord Incentives cohort will increase housing choices for voucher holders in the WMA. DHA's MTW program will allow voucher holders to live in mixed-income neighborhoods within the WMA, including the five counties under the Wiregrass Regional Voucher Program (WRVP) of Geneva, Houston, Dale, Henry, Coffee; and

WHEREAS, DHA is excited to enhance our relationships with landlords that have expanded housing opportunities for our voucher holders in the WMA. DHA's MTW selection has allowed the PHA to increase self-sufficiency, optimize our day-to-day operations through technology, and increase housing opportunities by adding more landlords to our portfolio; and

WHEREAS, DHA has invested in technology and implemented best practices to remove the bureaucratic red tape for the WRVP to develop better PHA-landlord relationships that have led to more affordable housing choices for voucher holders; and

WHEREAS, DHA will increase housing choices for voucher holders by utilizing mobility counseling, wrap-around services, and the Small Area Fair Market Rent (SAFMR) payment standards; and



WHEREAS, DHA will increase housing choices by expanding housing opportunities and deconcentrating poverty for voucher holders by providing access to jobs, good schools, healthcare, a healthy environment, healthy foods, safe neighborhoods, and transportation services through the MTW designation; and

WHEREAS, DHA's selection to be amongst the 28 PHAs chosen for the Landlord Incentives cohort for the MTW Demonstration Program with the ability to test ideas, concepts, and methods to serve better the communities in which they reside will be a game changer for affordable housing in the WMA. HUD understands that groundbreaking innovation should replace the "one-size-fits-all" approach for agencies to operate with best practices. As a part of the MTW Landlord Incentive cohort, DHA will display innovative thinking and demonstrate the capacity to initiate effective change that impacts the specific community, the nation, public policy; and

WHEREAS, DHA advertised the Public Notice in the Dothan Eagle, which the legal ad ran for four consecutive weeks on August 25, 2023, September 1, 2023; September 8, 2023; September 15, 2023; and

WHEREAS, DHA re-advertised the Public Notice in the Dothan Eagle, which the legal ad ran for four consecutive weeks on November 14, 2023, November 21, 2023; November 28, 2023; December 5, 2023; and

WHEREAS, DHA re-advertised the Public Notice in the Dothan Eagle, which the legal ad ran for four consecutive weeks on March 7, 2024; March 14, 2024; March 21, 2024; March 28, 2024; and

WHEREAS, a Housing Authority will advise HUD, its residents, and members of the public of the housing authority's mission for serving the needs of low-income, very low-income, and extremely low-income families and the housing authority's strategy for addressing those needs; and

WHEREAS, in accordance with HUD Regulations, DHA advertised in the Dothan Eagle, which the legal ad ran for four consecutive weeks on March 7, 2024, March 14, 2024; March 21, 2024; March 28, 2024; and

WHEREAS, DHA was granted flexibility and authority to develop policies in accordance with MTW for Expansion Agencies Operations Notice (Federal Register/ Vol. 85, NO. 168) FR/5994-N-05 outside the limitations of specific HUD regulations and provisions; and
